Parks

The Gurnee Park District operates 28 park sites and maintains about 416 acres of open space.

Staffing

The Park District employs 53 full time staff members and approximately 165 year round part time and 175 seasonal employees.

FREEDOM OF INFORMATION ACT REQUESTS:

The Gurnee Park District complies with the IL Freedom of Information Act ("FOIA"), (5 ILCS 140/1 et seq.)

Requests for public records must be submitted in writing to the FOIA Officer, Christina Richmond, Accounting Manager; at the Viking Park office, 4374 Old Grand Ave. Gurnee, IL 6003I (847-623-7788) or email: crichmond@gurneeparkdistrict.com.

For your convenience, the Park District has a standard form available upon request or on our website. If you choose not to use the form, the following information is requested:

- Requestor's full name, address and phone number. Include email address if you would like the response sent electronically.
- 2. A description of the records being sought, and whether the request is for inspection, copies of the records, or both.
- A list of commonly-requested documents is available for review upon request.

Fees: First 50 pages of black and white photocopies = free. Additional b/w copies= \$.15 each. CD's = \$.50 per CD. Oversize materials = at cost. Postage = at cost.

Upon approval of a request for public records, the Park District may either provide the materials immediately, give notice that the materials shall be made available upon payment of copying costs, or give notice of the time and place for inspection of records. The Park District may redact information that is exempt under Section 7 (1) of the Act.

Commercial requests for information, (those that seek to use public records for sale, resale, or solicitation or advertisement for sales or services) will be handled expeditiously. However, the Park District may take up to 21 business days to respond to this type of request.

Categorical requests that create an undue burden on the Park District shall be denied only after giving the requester an opportunity to confer with the FOIA officer in an attempt to reduce the request to manageable proportions in accordance with Section 3(g) of the FOIA.

Any denial of a request shall be made in writing. It shall state the reasons for the denial and the names and titles of individuals responsible for the decision. It shall also inform the requestor of the right to seek review from either the Illinois State Attorney General's Public Access Counselor or from a court within 60 days of the denial.

The Gurnee Park District was established by local referendum and incorporated in 1968 as a special purpose unit of government as provided by the Illinois Park District Code.

The Park District has the power to levy taxes within its prescribed limits and possesses all of the powers of a public corporation.

PURPOSE

It is the purpose and objective of the Gurnee Park District to provide and maintain sufficiently attractive parks throughout the area we serve, to provide leisure time activities for all the people of our community and to provide wholesome recreation for the entire family.

We will seek to secure funding from grants, land donations and other means to provide facilities without directly adding to their taxes.

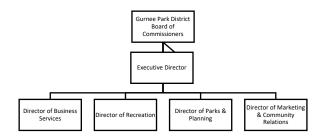
We will promote pride in our area by providing our community with parks of which they can be proud.
